SUPPORTS IREM'S INTERNATIONAL **GROWTH WITH 66** MILLION SYNDICATED LOAN TOGETHER WITH BANCO BPM



(Teleborsa) UniCredit supports IREM's international growth with 66 million syndicated loan together with Banco BPM. IREM, says a note, the company established in 1979 with registered office in Syracuse, which today operates as the main constructor for large mechanical works and in the design, construction, planning and assembly of industrial plants of all kinds, has been awarded a contract in Hungary, with ThyssenKrupp as client, for € 170 million in 18 months. The bank and the insurance support was decisive during the contractual phase for the beginning of the works. In detail, UniCredit sustained IREM with the issue of bonds for a total of 36 million (18 million of Advance Payment Bond and 18 million of Performance Payment Bond), with TyssenKrupp as beneficiary, through the intervention of UniCredit Bank AG, as guarantor, with a counter-security in syndication with Banco BPM. In addition, UniCredit Factoring, with Banco BPM and UniCredit Leasing as a syndicate, will sustain the works and the construction site with ad hoc lines of credit, namely 23 million and 7 million, to support the order economically.

"I am very glad - says Giovanni Musso, CEO of IREM spa - to have finalized such an important and complex financial transaction, coordinated by UniCredit and with the significant participation of Banco BPM, necessary for
